## TKU Regulations for Managing the Posters and Banners of Association Activities

Secretariat Regulation No. 1030000018 (06/16/2014)

#### Article 1

In order to increase the appeal of the activities held by various associations, they display posters and banners on campus; and thus to insure the maintenance of cleanliness, attractive appearance and the safety of student traffic on campus, this set of regulations has been especially enacted.

## Article 2

The posters and banners of various kinds of activities need to undergo a process of application and approval before they can be displayed.

## Article 3

With the exception of being displayed at permitted sites such as Poster Street, the poster boards and bulletin boards of the various buildings, posters cannot be haphazardly placed on the external walls of buildings, the road surface, tree trunks or lamp posts.

## Article 4

Posters displayed on Poster Street require the stamp of "For Use Only on Poster Street".

## Article 5

The number of activity posters allowed for display will be apportioned by the Extracurricular Activities Guidance Section based on the actual situation. The allowed time for display is limited to 7 days (including holidays).

## Article 6

Off-campus posters, except for the posters of activities held by the associations of other universities and colleges, must promote cultural activities or activities of public benefit and have the stamp of "For Use Only on Poster Street" from the Extracurricular Activities Guidance Section before they can be displayed; the number of posters is three limited to seven days.

#### Article 7


Double-sided tape, staples, quick-drying liquids and any products that are able to damage the wall surface are prohibited for use in posting posters.

## Article 8

The area in which banners can be displayed is indicated in the campus banner display map.

## Article 9

The specifications of size for the banners are 5 meters high and 2 meters wide.



## Article 10

The applying office should send someone every day to patrol and set upright any fallen banners. If the office does not comply on this point and someone is injured or someone's vehicle is damaged, they must be responsible by themselves.

## Article 11

The number of banners and their placement will be apportioned by the Extracurricular Activities Guidance Section based on the actual situation.

## Article 12

The advertisements of business sponsors of the activities cannot exceed more than one third of the area of the whole banner.

## Article 13

Banners or promotional streamers cannot be affixed to the outside walls of the various buildings, halls, dormitories and streetlamps or tree trunks.

## Article 14

Banners and posters can be displayed according to the approved time limit of the Extracurricular Activities Guidance Section. On the day the limit is terminated, all banners and posters should be promptly removed.

# Article 15

For an association that violates the above regulations, the Extracurricular Activities Guidance Section can take the disciplinary action of not allowing the association to display any posters or banners from one to two semesters.

# Article 16

This set of regulations will take effect on the date of its publication after being passed by the Office of Student Affairs Senior Staff Meeting and approved by the TKU President. The same applies to any later amendments made.
